Scientific Beta Pte (hereinafter referred to as 'we' or 'us') is committed to protecting your personal data and to maintaining your privacy when using the Scientific Beta services. This Privacy Policy describes how we handle your personal information collected when engaging with Scientific Beta, including:

- Via the Scientific Beta website, you can browse through the Scientific Beta website without providing any personal data. However, in certain cases, you may need to provide your personal data to access specific services on the website.
- In the context of the execution of a contract with an organisation you are associated with.
- By registering and/or participating in one of Scientific Beta's events.
- By submitting a free application or applying to a published job offer.
- By corresponding with Scientific Beta Client Services or any of our representatives.

1. Information we collect

1.1. When you visit our website as an unregistered user, no personal data about you is collected by us. We only collect and store the current IP address of your computer, date and time of access, browser type, computer operating system, and a record of the pages you visit on our site. This information is logged for statistical and security purposes, as well as to enhance our website. It is not possible to identify the data subject from this information.

1.2. When you contact us directly or subscribe to the password-protected area of the Scientific Beta website, we will collect personally identifying information from you. This information may specifically include your first name, last name, company, position, address, email address, and telephone number.

1.3. When your related organisation provides us with your personal information, including your first name, last name, company, position, address, email address, and telephone number, for the purpose of contract execution or prospection.

1.4. When registering for a Scientific Beta event, including seminars, webinars, masterclasses, conferences, surveys, or any other type of event that requires registration.

1.5. When applying for recruitment, we collect the personal data that you submit to us, which may include personal details, information about previous employment, education, qualifications, social media accounts, areas of interest, and any other relevant information.

1.6. Scientific Beta e-mailings include an invisible single-pixel image that is used to gather general statistical information on whether an electronic message has been opened and read, along with the geographical location. This data is used to improve the content provided to the recipient.

2. How we use personal data

2.1. We may track and analyse your use of the Scientific Beta website and use your personal data for the following purposes:

- To provide you with news and reports, according to your subscription;
- To provide you with information on new or existing products and services;
- To support the development of the Scientific Beta website, our products, and services;
- To personalise the content of the Scientific Beta website;
- To verify your authorisation to use the Scientific Beta website;
- To monitor compliance with the applicable terms of service regarding your use of the Scientific Beta website;
- To execute a contract between Scientific Beta and the organisation you are associated with;
- To manage your participation in Scientific Beta events or third-party events sponsored by Scientific Beta; and
- To engage in a recruitment process with Scientific Beta.

2.2 The purposes listed in the above paragraph all have a legal basis which is either contract execution, consent, or legitimate interest.

2.3. To the extent legally permitted, we may also use and disclose personally identifying information in special circumstances where it is necessary to enforce our rights (for example, when necessary to protect our intellectual property or contractual rights). We may also disclose or use your personal information when the law requires us to do so.

2.4. Scientific Beta aims to retain your personal data collected for no longer than the completion of the purpose collection as per the terms of the Scientific Beta Document Retention and Destruction Policy.

3. Cookies

3.1. A cookie is a string of information that is sent by a website and stored on your device. Cookies may contain various information related to website visits and can be used to identify your device. You have the option to delete the cookies stored on your device at any time.

3.2. We employ cookie technology primarily and solely to facilitate access procedures and provide the requested services. Our cookies are strictly necessary for the functioning of our website and are not used to collect personal data. They are transient cookies that are designed to be deleted by Internet browsers at the end of each session. However, since certain browser configurations may allow cookies to persist, we have implemented measures to ensure their timely expiration. For general website access, we do not accept cookies older than 24 hours, and for access to password-restricted pages, we do not accept cookies older than 4 hours. Whenever a cookie is deleted or expires, you will be prompted to confirm your agreement with our website's terms and conditions again and/or to re-enter your username and password for accessing password-restricted pages.

3.3 We employ [Matomo Analytics](#) technology to collect usage data used purely for statistical purposes or to improve our website. We do not send data that might identify users to Matomo Analytics or any of its partners.

3.4. You are informed that by accepting Scientific Beta's website [Terms of Service](#) you consent for the usage of cookies and personal data as set out in the paragraphs above.

4. Security

Scientific Beta is dedicated to ensuring the security of your personal information. To achieve this, several technical and organisational measures have been implemented to protect and preserve the integrity of your personal data. These measures include, but are not limited to, limiting access to authorised personnel only, storing data on secure servers, data encryption, and safeguarding your personally identifiable information against accidental or intentional manipulation, loss, destruction, and unauthorised access. We continuously enhance our security procedures to incorporate new technology as it becomes available.

Please note that your password is personal and strictly confidential. If you forget your password, you can request a password reset online. However, we are unable to retrieve and provide you with your current password. For security reasons, we do not store personal account details for payment purposes.

5. Transfer of information

5.1. Personal data is stored on our servers, which are currently located in France, the United Kingdom, and Ireland. If you are located outside of these countries, please be aware that the information you provide to us may be transferred to and stored in any of these locations. By registering for any Scientific Beta services, including job applications, you give your consent to this transfer and the storage of your data in these locations. Regardless of where your information is stored or processed, Scientific Beta applies the same safeguards as described in this policy.

5.2. Please be aware that we reserve the right to relocate our servers or process your information outside of the aforementioned countries, as permitted by the applicable data protection laws. By subscribing to the password-protected area of our website, using the Scientific Beta website, or submitting a job application, you also consent to the potential transfer of our servers.

6. Data subject rights

Data subjects are informed that they have the following rights under this privacy policy:

6.1. Right to be informed

You have the right to know your personal data that is processed by Scientific Beta, personal data usage, as well as personal data applicable rights.

6.2. Right of access

You have the right to request access to the personal data we hold about you and obtain information regarding its processing.

6.3. Right to rectification

If you believe that the personal data we hold about you is inaccurate or incomplete, you have the right to request its correction or update.

6.4. Right to erasure

You have the right to request the deletion of your personal data in certain circumstances, such as when it is no longer necessary for the purposes for which it was collected or if you withdraw your consent.

6.5. Right to restrict the processing

You can request the restriction of the processing of your personal data under certain conditions, such as when you contest its accuracy or the lawfulness of processing.

6.6. Right of data portability

You have the right to receive your personal data in a structured, commonly used, and machine-readable format, and, if feasible, to transmit that data to another data controller.

6.7. Right to object

You have the right to object to your personal data processing when its legal basis is based on legitimate interest.

6.8. Right to withdraw consent

If we rely on your consent to process your personal data, you have the right to withdraw your consent at any time.

7. Data subject rights exercise

You can exercise the rights listed in the above paragraph 6 by following these steps:

1. Accessing your profile in the password-protected area of the Scientific Beta website: You can update and correct your personal data by logging into your profile in the password-protected area of the Scientific Beta website.
